# Objectives and Methods

- Adults 50+ make up large proportion of people living with HIV (PLHIV) in Canada (1), due to increased life expectancy (2)
- It is necessary to investigate services available to this growing demographic to address service gaps

## We set out to:

- 1 Provide an overview of programs available to older adults living with HIV (OALHIV) in British Columbia, Canada
- 2 Identify whether home and community care services are being supplemented by Community-Based Organizations (CBOs)

- Potential CBOs first identified by a Peer Research Associate (PRA) and online scan
- Organizations invited to participate if mandate included providing support to PLHIV
- N=30 CBOs across the five regional health authorities agreed to participate in a short phone interview, co-administered by a PRA in 2018



# Findings: Service Availability

## Most Offered Services Across British Columbia

- Food Security Assistance (90%)
- Support Services (83%)
- Outreach Services (80%)

## Least Offered Services Across British Columbia

- Vocational Counselling (13%)
- Financial Aid (27%)
- Medical/Dental Services and Alternative Therapy (33%)

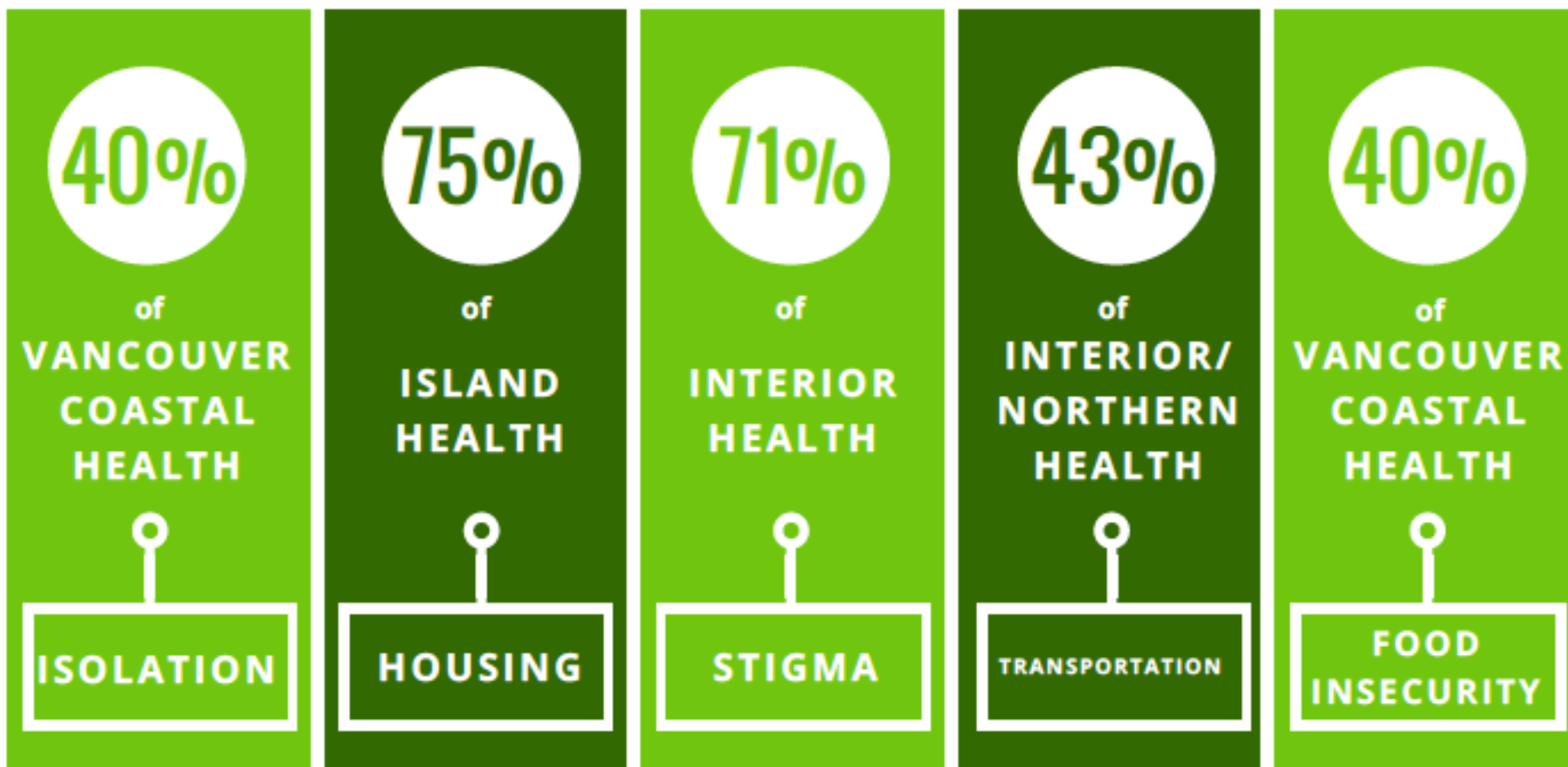

# Findings: Challenges with Access



The figure above outlines the percentage of organizations within a given regional health authority that reported specific challenges faced by older adults with accessing services. This question was open-ended in the survey.



# Conclusions

- Community-based organizations are providing services for PLHIV that may be lacking from formal care services
- There remain challenges experienced by OALHIV which may impede access to these services
- Note that this survey was conducted in 2018, and participating CBOs may have since altered their services
