



## HIV/AIDS Drugs available through the BC-CfE Drug Treatment Program

The medications listed can be requested by completing and submitting an HIV Drug Treatment Program Prescription Request Form. Requests will be assessed according to established therapeutic guidelines. Clinical justification and/or supportive documentation may be required. Eligible individuals will obtain, at no cost, medications offered by the BC-CfE's Drug Treatment Program.

### Drugs for the Indicator Diseases of AIDS covered by the program

- Atovaquone — One-time treatment for PJP, treatment for unresponsive toxoplasmosis, third-line PJP prophylaxis
- Azithromycin — Prophylaxis for MAC, treatment for unresponsive toxoplasmosis
- Ciprofloxacin — For clarithromycin-resistant *Mycobacterium avium* infections (MAC)
- Clarithromycin — *Mycobacterium avium* infections (MAC)
- Ethambutol — *Mycobacterium avium* infections (MAC)
- Filgrastim - HIV treatment-related - neutropenia
- Ganciclovir, infusion & intravitreal — Cytomegalovirus (CMV) affecting sight or organ system
- Rifabutin — *Mycobacterium avium* infections (MAC)
- Valganciclovir — Cytomegalovirus (CMV) affecting sight or organ systems

### Drugs available through Health Canada's Special Access Program

- Albendazole — Microsporidium
- Foscarnet, infusion — Cytomegalovirus (CMV) affecting sight or organ systems
- Nevirapine liquid (Viramune®) — for children
